I am writing regarding the grant application made by the Community Foundation on behalf of Rockbridge Recovery related to a proposed sober living home to be located here in Buena Vista. I want to register my support for the grant and for the project.

Substance abuse is a significant problem here in Buena Vista and much of the attention and resources devoted to criminal justice matter relate directly or indirectly to drug use. It is not uncommon for a defendant to come through the criminal justice system multiple times with problems stemming from drug use. Often part of the disposition of the case is to order a defendant to undergo drug treatment. Many litigants seek out such services while their cases are pending as well.

Although our community has some resources for treatment, those resources are stretched thin. In addition, we don't currently have a sober living facility available locally for our population. Sober living houses are often a key part of a recovery journey for individuals with the most intractable addictions. I have experienced in my own the work the effectiveness of these types of facilities in recovery. I believe having a local community based sober living house would be a significant benefit for our criminal justice system and for the community itself.

Please find this letter in support of the Community Foundation and Rockbridge Recovery's initiative to establish the HOPE House project in Buena Vista, Virginia. Addiction and substance abuse are prevalent throughout our country, and Buena Vista and its surrounding areas continue to suffer from the effects of opioid abuse and addiction to other illicit substances. To date, our community has lacked enough collaborative efforts and funds for initiatives, and facilities, such as the planned HOPE House project, which work to combat the growing needs of community members related to addiction and substance abuse.

I have worked as a law enforcement officer in Buena Vista since 2010. Most of my career has been spent investigating narcotic related crimes with task forces on the local, state, and federal levels. Through the years, this experience helped my own world view related to addiction and substance abuse to evolve and develop to an understanding that our problem cannot be fixed by law enforcement efforts, or by any one initiative alone. Crime prevention techniques, proactive intervention, education, and recovery programs are all crucial programs needed to begin to break the trend of increasing numbers associated to substance abuse and addiction.

A large majority of crimes committed in Buena Vista have a nexus to drug addiction and illicit substances. Community members suffering through substance abuse make outrageous choices when chasing the need which develops from their addiction. Theft, fraud, and financial exploitation are often ways that addicts find to feed their addiction. Additionally, my department responds to domestic assaults, fights, child neglect, people in crisis and in need of

mental health evaluations, and incidents of abuse that are often attributed to an addict's frustration and/or irritability often stemming from symptoms developed during their systems' detoxification from specific substances. Subsequently, our officers are responding to an increasing number of overdose deaths. Unfortunately, addiction impacts family, friends, teachers, mentors, and so many other persons than just the addict themselves.

My community has experienced too much grief and sadness related to addiction. Now more than ever, collaboration and conceptualization to combat substance abuse and addiction are essential to ensuring that these trends do not continue. Looking at the concept for the HOPE House project, I believe it will be vital to helping its tenants continue through their recovery and to provide accessible aid and accountability to these persons as they acclimate into our communities.

Please accept this letter of support for the HOPE house project and the Community Foundation for Rockbridge, Bath, and Alleghany. Substance abuse recovery is a lifelong journey that does not end with the completion of a detox or rehab program. To remain sober, individuals need a support system that provides constant commitment and care. Through the establishment of sober living homes, individuals will have a nurturing and judgment free environment that allows recovering addicts to combat societal triggers, which can routinely cause addiction setbacks.

As a police chief with over 20 years of law enforcement experience, the drug epidemic is a complex social illness that requires the assistance of multi-disciplinary partners to work together for a comprehensive solution. The illegal use of narcotics can be linked to many offenders who commit major crimes in our city and therefore pose a threat to public safety. It is apparent that arresting individuals will not solve the problem, but constant mental health, support and wrap around services throughout an addict's life will greatly improve their chances of a productive way of life and reduce recidivism. The drug epidemic is a public safety concern that we are committed to reduce, to protect all individuals, and increase their sense of safety in the workplaces, schools, and homes. More importantly, we want to assist citizens re-entering society with viable chances of success, which hinges on a stable home and supportive environment.

Throughout our community, police officers routinely encounter people who have substance use disorders (SUDs). Nationwide statistics have shown that adults arrested in the past year for serious offenses were four times more likely to have used illicit drugs compared to those who did not use drugs. Furthermore, it is estimated that individuals with SUDs make up 68% of the jail population and 53% of the state prison population, yet only 12% of the incarcerated population will receive drug treatment while they are in custody. This is a contributing factor to the high recidivism rate of narcotics users. These high-risk individuals are likely to continue their destructive behaviors upon their return to society, absent treatment for their disease of addiction, having a stable home environment, and provided social services.

The HOPE house project is a vital and foundational program that offers a empathetic sober living environment for those who wish to continue a healthy and productive lifestyle. I enthusiastically support the HOPE project which will provide individuals struggling with drug addiction, the basic human needs and wrap around services required to break the cycle of drug addiction. This project represents an innovative and holistic solution to reduce illicit drug use in our community, which will create a safer city and enhance the quality of life for all community members. Moreover, this project combines the wrap around services of 15 community partners dedicated to providing their expertise as a vital component to solve this wicked problem.

With regards to the capability of the Community Foundation, this organization consistently fundraises to support initiatives and lead community projects with professionalism, equity, and respect for all participants. This agency has a proven track record for their commitment to uplifting and supporting our citizens through recent initiatives that provided \$880,000 in COVID-19 pandemic funding which provided for residents' critical needs; as well as managing the Walker Program, which has raised over \$300,000 to assist minority individuals open their own businesses within our community. I consider my desire to advocate for this project as a moral obligation, a civic duty and affirmation of my values regarding empathy and tolerance for those in helpless and unfortunate situations.

The Lexington-Rockbridge Circuit Court has prosecuted at least 522 felony cases and of those, 189 or 36% included a drug charge. Those statistics do not include serious crimes where drugs may have been a factor, but not charged. For this region, the numbers are too significant to ignore in a small community.

As a 4-term member of the Lexington City Council, I am aware of the community effects of addictions, not only incarcerations, how that affects the local economy, services to support families and children, medical care, mental health care, housing opportunities, education, and training. Every facet of our lives can be potentially affected in various ways directly or indirectly by community addictions and addictive behaviors.

The affordable housing industry requires the completion of a rehabilitation program to consider housing applicants with patterns of substance abuse. In western Virginia, the opportunity for rehab has been slim to none. Although the affordable housing industry greatly limits those with a history of drug convictions, more opportunities may open for rehabbed applicants. Having worked in the management of affordable housing for the last 24 years, it is *my* hope to see the success of the Hope House, which would increase the likelihood of landlords in the business of offering homes vs. turning them away to a life of homelessness.

As a member of the Board of Directors of the Carilion Rockbridge Community Hospital, I am aware of the challenges in the medical care industry to provide the unique and intensive assistance needed in the care of substance abuse patients, finding beds for the additional care required to turn their lives around. Having a local choice would be a cost-effective option for the patient, their families and for law enforcement agencies charged with transporting them safely to facilities to receive necessary care.

Our community is making every effort to provide in-kind support but financial support, dedication, local and regional partnerships, and the collaboration of our community leaders are all crucial to the success of a service of great benefit to the Lexington-Rockbridge-Buena Vista area.
