	We are asking the OAA to award a grant for the purpose of establishing a Comprehensive Psychiatric Emergency Program (CPEP) and acute, inpatient behavioral health unit consisting of 20 beds. Both would support evidence-based withdrawal management services for people with opioid use disorder (OUD) and any co-occurring mental health conditions. These services would be provided through a partnership with Chesapeake Regional Healthcare (CRH). Neither a CPEP or inpatient psychiatric unit currently exist in the city. The total time necessary to construct and implement both services is 18-24 months. Grant funding would provide the final funding needed to begin construction of both units. CRH would assume all ongoing operational costs associated with the newly introduced services.

c. Describe the objectives of this project

- 1. Funding from this grant will create a streamlined, bi-directional point of access to opioid use disorder (OUD) treatment.
- The new service lines will provide a safe and therapeutic setting to conduct a clinical assessment of community members to determine if they have OUD or any co-occurring mental illness.
- 3. Both the Comprehensive Psychiatric Emergency Program (CPEP) and inpatient behavioral health unit will provide evidence-based treatment platforms for those patients determined to have OUD and any co-occurring mental illness.
- 4. For those who do not require extended observation or inpatient admission, our program will provide MAT (medication assisted treatment) and connect the individual to least restrictive community resources including individual therapy, support groups, or clinics who provide longterm MAT.
- d. How was the need determined and how does that need relate to abatement?

Research indicates that co-occurring substance use and mental disorders are common among adults with opioid use disorder (OUD). Individuals who need medication assisted treatment (MAT) for OUD and any co-occurring mental illness have limited options to turn to in the city. Further, when citizens seek treatment, current options prohibit timely execution of appropriate treatment. The City of Chesapeake, the Commonwealth's second most populous city, currently only provides outpatient based services. Chesapeake Regional Healthcare (CRH) currently offers the Prevention and Recovery from Opioid Use Disorder (PROUD) program, which connects individuals to these outpatient based services. This July, Chesapeake Integrated Behavioral Health (CIBH) plans to open a crisis receiving center, a 23 hour observation unit appropriate for lower acuity patients. However, the need for hospital-based emergency psychiatric care is critical for higher acuity patients. Inpatient psychiatric beds will provide additional treatment options for those with the severest needs. Without these critical services, these individuals are at risk of overdose. Approximately 20 or more overdoses are treated at CRH monthly.

Within our region, nearly 400 people die annually from opioid overdose, accounting for 15.9% of the state's opioid overdose deaths. Fifty five of those are citizens of Chesapeake. Across the state, opioid overdoses have increased by 16.4% over the past year. Targeted beneficiaries will include individuals with opioid use disorder (OUD) and any co-occurring mental illness. An aggressive public awareness campaign will be part of educating the community of the new OUD treatment options within the city.

The Comprehensive Psychiatric Emergency Program (CPEP) and inpatient behavioral health unit will be located inside Chesapeake Regional Medical Center (CRMC). CRMC is a non-state-owned, public hospital. It does not receive appropriated funds from the Commonwealth's General Fund, so to establish new service lines, it must rely on profits from revenue generated by the care it provides to those who seek it. The design of both units will be done by PF&A, a renowned architect that specializes in state of the art treatment environments in the healthcare sector. Locally, they were the designers of the new CHKD behavioral health tower.
