Overview of Proposed Grant Program:

Summary of Staff Review and Recommendations
The participating cities and counties are partnering with the Rappahannock Area Community Services Board (RACSB) for both of these projects. RACSB runs the MAT program at the Fredericksburg clinic and runs the Sunshine Lady House Crisis Stabilization Center. The objectives of these projects are to 1) provide access to medication for individuals with Opioid Use Disorders in all localities within the catchment area at least once/week, 2) enroll at least 5 people per mobile unit locality within the first two months, 3) Decrease overdose rates through improving access to treatment and naloxone, 4) reduce emergency or inpatient hospitalizations to address the needs of individuals experiencing co-occurring behavioral health crisis, 5) mitigate the high correlation between mental health challenges and substance use, and 6) Provide comprehensive patient care to stabilize individuals and promote access to on-going community treatment.
All participating cities/counties are providing a match from their individual distribution representing the percentage of their residents served by RACSB. Total match is \$247,000 (26.2%) and is to the expansion of detox for women. The total match is pledged for each year of the 5-year proposal.
Staff recommends full approval with the following contingencies before the OAA funds will be transmitted: 1) All cooperative partnership projects are expected to complete an operational agreement between all partners. 2) For any awards involving capital costs for real property, an agreement will be executed between the fiscal agent and subrecipient/vendor that ensures the facility will remain in operation for at least 15 years or funding will be returned to the OAA with the option at the OAA's discretion that it will accept payment at a rate of depreciation based on the subsequent years the facility was expected to operate. Additionally, the project should achieve sustainable funding without OAA assistance by EY29.
