Powhatan County is seeking a planning grant to engage a firm to complete a comprehensive strategic plan to guide Powhatan County's "community-wide opioid abatement report and plan."

Summary of Staff Review and Recommendations
Powhatan has developed a request for proposals (RFP) for professional consulting services to guide the County in developing a strategic opioid abatement plan that would integrate early intervention/prevention, evidence-based treatment, criminal justice diversion, employment services, recovery support services, housing support, and re-entry programs. The plan would identify community stakeholders, financial planning, and various other strategic elements. The proposed cost total \$175,000 with Powhatan providing a 10% match (\$17,500) from its direct distributions, resulting in an OAA request of \$157,500.
Staff recommends partial funding of \$45,000 which, combined with Powhatan's 10% match of \$5,000 would set the budget at \$50,000 total. After evaluating proposals, Powhatan would be encouraged to apply for an amendment, if necessary, should the \$50,000 budget be insufficient. Such an amendment could be timely considered by the OAA Grants Committee and Board. It is also recommended that any award be conditioned on Powhatan County agreeing to include cooperative procurement language in its RFP and eventual contract(s) consistent with Code of Virginia §2.2-4304.
