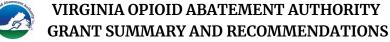

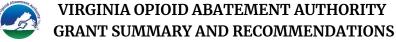

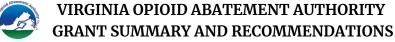

Project	Roanoke City has proposed an amendment/renewal of the certified peer recovery specialist project. This project will hire a cerified peer recovery specialis (certified by the Department of Behavioral Health and Developmental Services) to work within the sheriff's department at the Roanoke City Adult Detentio Center. This position will assist in working with individuals to facilitate readiness for treatment, engagement in treatment, retention in services, and long-										

Project Center. This position will assist in working with individuals to facilitate readiness for treatment, engagement in treatment, retention in services, and longterm recovery. The proposal notes the benefits of linking individuals with peers, especially for vulnerable populations to include individuals who are justiceinvolved, housing insecure, mental health issues, OUD and/or SUD, and co-occurring MH/SUD. Project was delayed in FY24, so funding will be used in FY25 with existing funding already received.

Staff Review and Recommendations The project is requesting carry forward of the FY24 award for the full amount awarded of \$61,000. No new funds are being requested for FY25 but renewals are requested for FY26 through FY28 to continue the project. Currently, available funding from individual funds and gold standard funds would not be Summary of Staff Review: sufficient to cover project costs for the renewal years, so the city would need to increase matching funds for the out years to be able to support the project costs from their direct distribution funds and/or other revenue sources.
