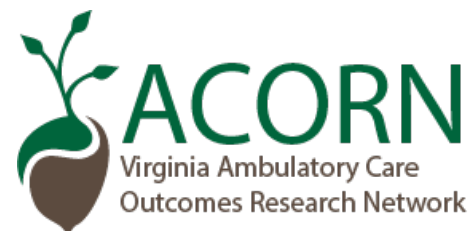

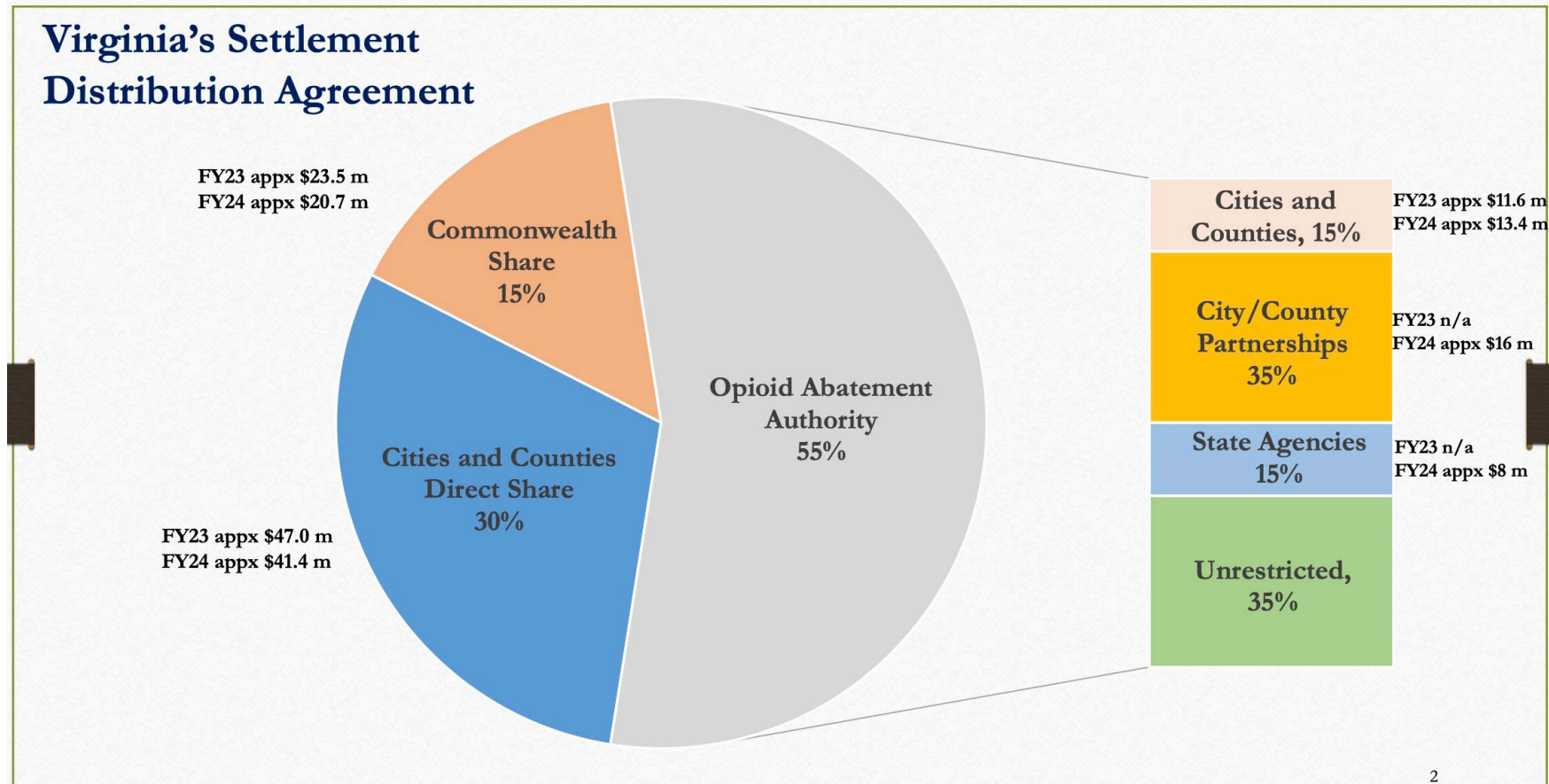

The OAA Toolkit

- Evidence-based toolkit for **cities and counties** to aid **apply for** and **use** OAA funds
- Online resource with **community-specific** data: direct communities to evidence-based practices and resources for prevention/treatment that are more likely to succeed in their community
- Facilitate partnerships

Chief Components of the Toolkit

- Build a toolkit based on the nine opioid settlement use categories from Exhibit E
- Evaluation of gaps and what is needed
- Research, compile, and evaluate promising interventions to determine whether they belong in the toolkit
- Community outreach
- Provide consultation to cities and counties

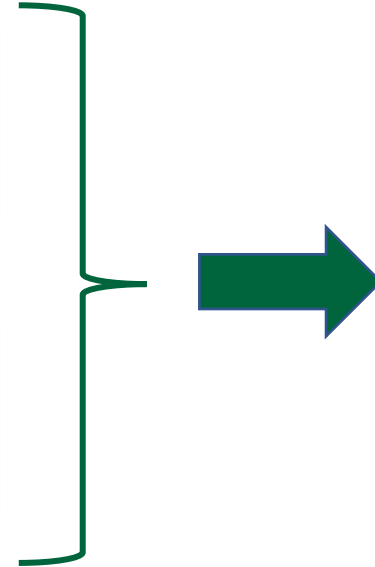

Chesterfield Sheriff's Helping Addicts Recover Progressively (HARP)



- Est. 2016, the opt-in program for incarcerated individuals
- Has served **over 3,000+** with breaking the cycle of incarceration
- Wide range of therapies
- HARP provides access to **recovery housing after incarceration**

Carilion ED Bridge to Treatment Program

- Launched in 2018, ensures a seamless transition for OUD patients from ER care to long-term recovery (prescriptions, peer guidance, and access to treatment)
- Rates of follow up (for ER patients with OUD symptoms) increased from 10 to 82 percent

Chesterfield EMS Mobile Integrated Health Team and Peer Recovery Specialists

- In 2014, Chesterfield County embedded a Mobile Integrated Healthcare (MIH) unit within their Fire and EMS force
- In 2017, partnered with local CSB to incorporate **Peer Recovery Specialists** into their established MIH teams
- Provide home visit, naloxone, and facilitates connections with other community services and treatment centers

City/County (OAA Grantee)	Intervention	Outcomes
Accomack County	Partner with Eastern Shore CSB to enhance harm reduction, prevention education, and clinical services	<ul style="list-style-type: none"> • Mental health care to over 50 incarcerated individuals • 400 adults linked to peer recovery support • 90 individuals have accessed therapeutic services • 530 individuals engaged in harm reduction efforts
Buena Vista County	Opened the HOPE House in April 2024, recovery housing	<ul style="list-style-type: none"> • Prevention education and awareness to 353 children and 10 professionals • More than 60 individuals engaged in harm reduction efforts • Successfully diverted multiple individuals from incarceration • Connected incarcerated individuals to peer recovery specialists to develop substance use disorder-specific release plans
Culpeper	Partnership with volunteer EMS stations	<ul style="list-style-type: none"> • Trained 98 individuals in the REVIVE program • Distributed 2,175 harm reduction kits • Team of 4 PRS have connected over 50 adults to detoxification services and provided peer support to 115 individuals

City/County (OAA Grantee)	Intervention	Outcomes
Louisa County	Region Ten has opted to expand its services using OAA funds	<ul style="list-style-type: none"> • Connected more than 130 individuals with counseling services and are aiming to hire a new clinical counselor • Engaged over 500 individuals in harm prevention outreach • Distributed more than 100 naloxone kits and fentanyl test strips
Smyth County	Partnership to provide medication-assisted treatment through office-based opioid addiction services	<ul style="list-style-type: none"> • Hired a Peer House manager • The associated localities have served over 190 individuals by offering therapeutic counseling services, professional mental health care, connections to employment, peer recovery services, and medications for opioid use disorder
Stafford County	Utilizing opioid abatement funds for data collection efforts; acquired the First Watch software	<ul style="list-style-type: none"> • The county has successfully identified geospatial hotspots for opioid use and promoted community interventions in those areas • First Watch software enables the EMS team to monitor overdose patterns in real time, resulting in the reversal of over 15 non-fatal overdoses

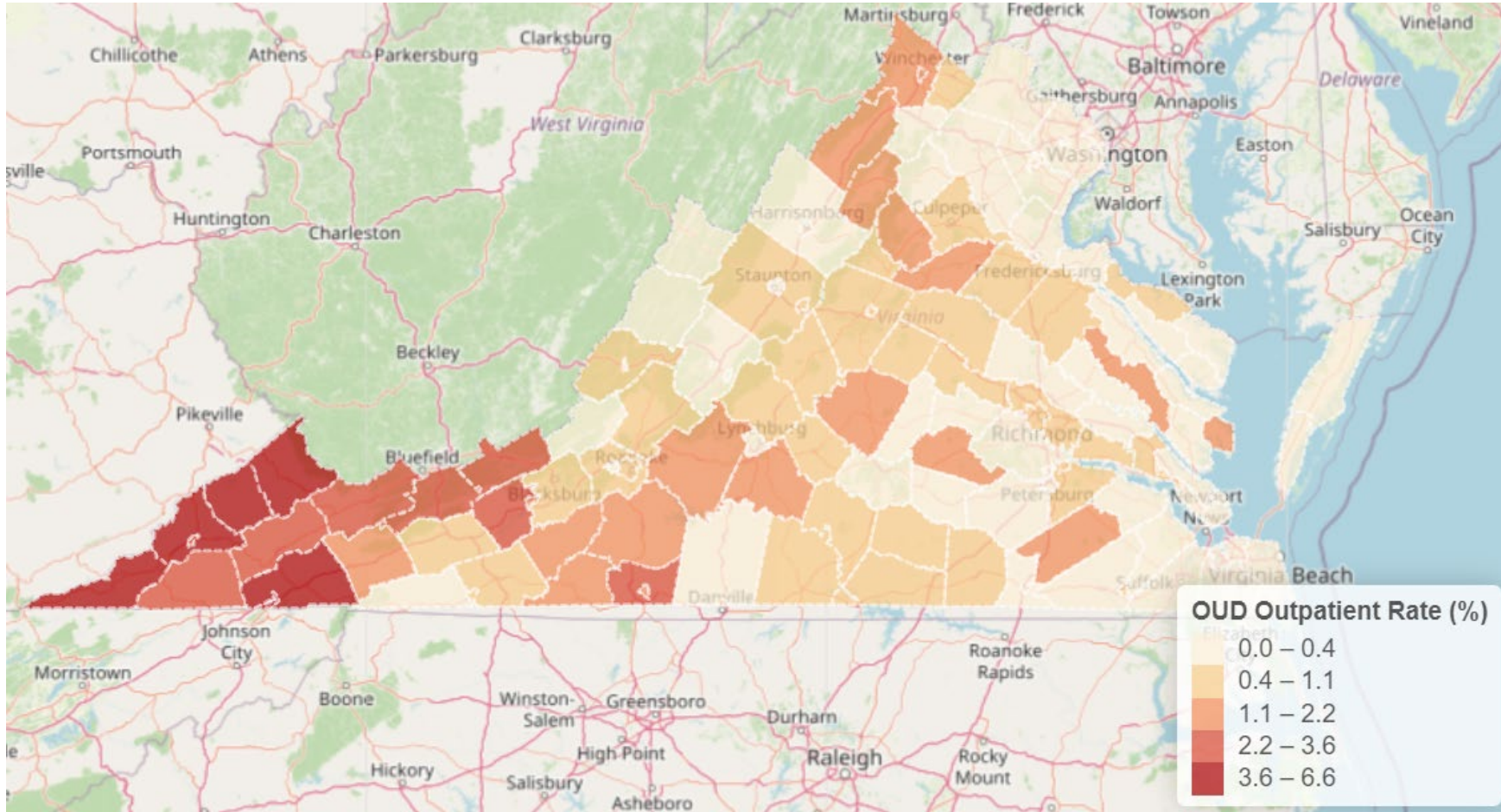

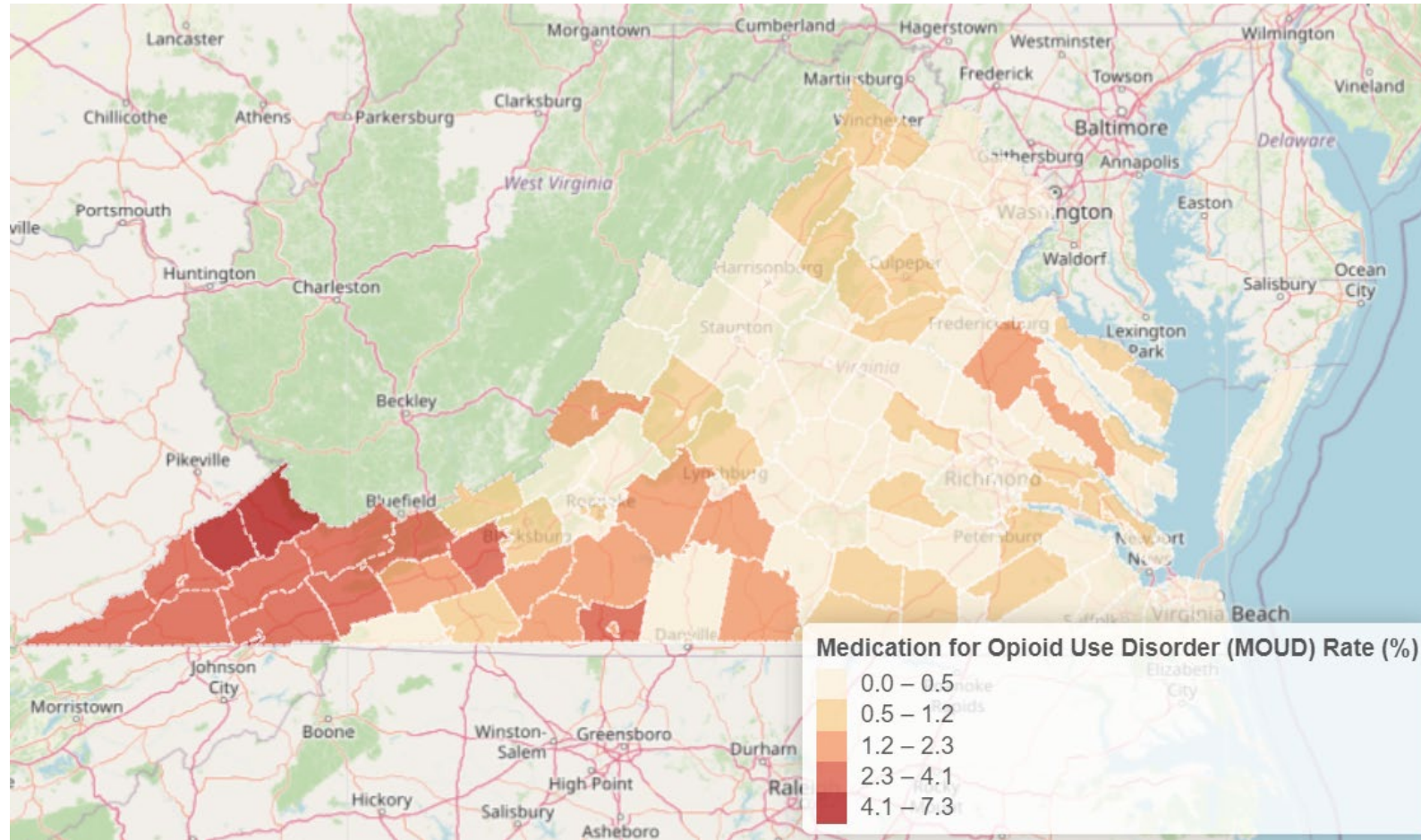

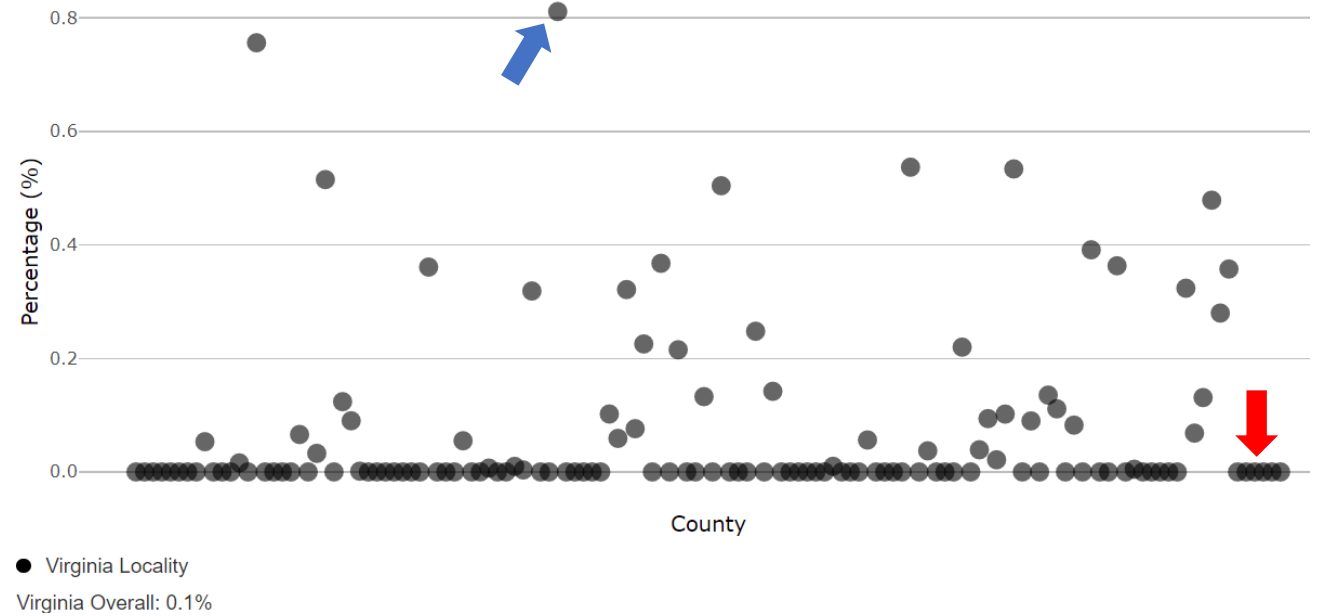
Pregnancy Outcomes: Outpatient Diagnosis Opioid Use Disorder



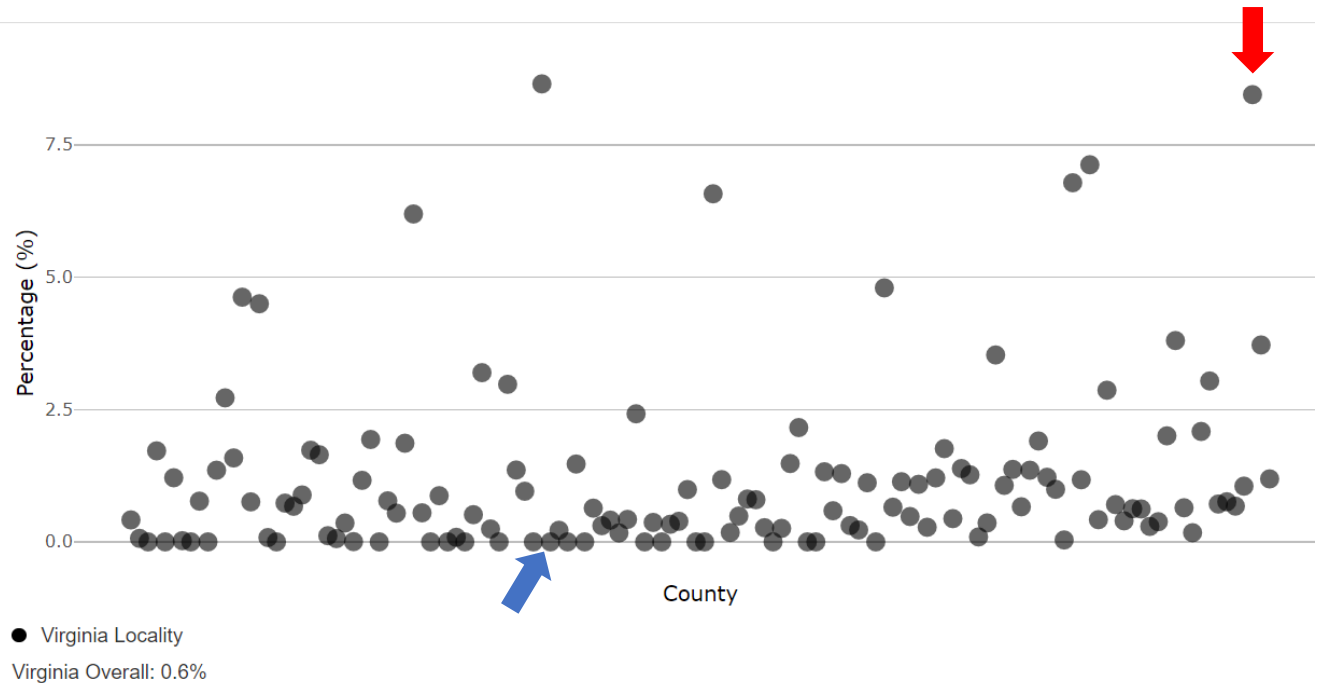
Pregnancy Outcomes: MOUD for Pregnant Women with OUD



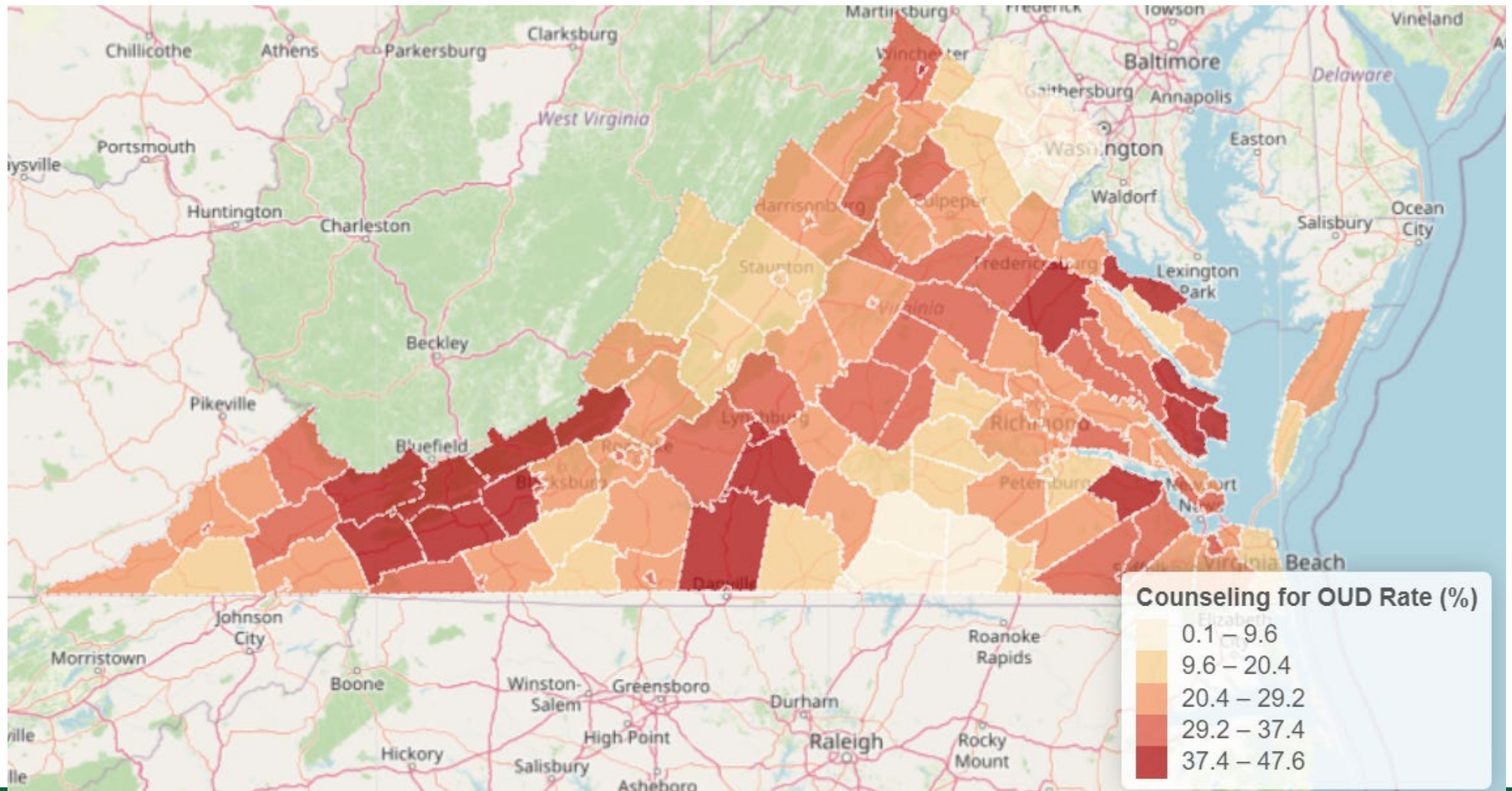
Rate of ER Visits for Opioid Overdose among Postpartum Women by County



Rate of MOUD among Postpartum Women by County



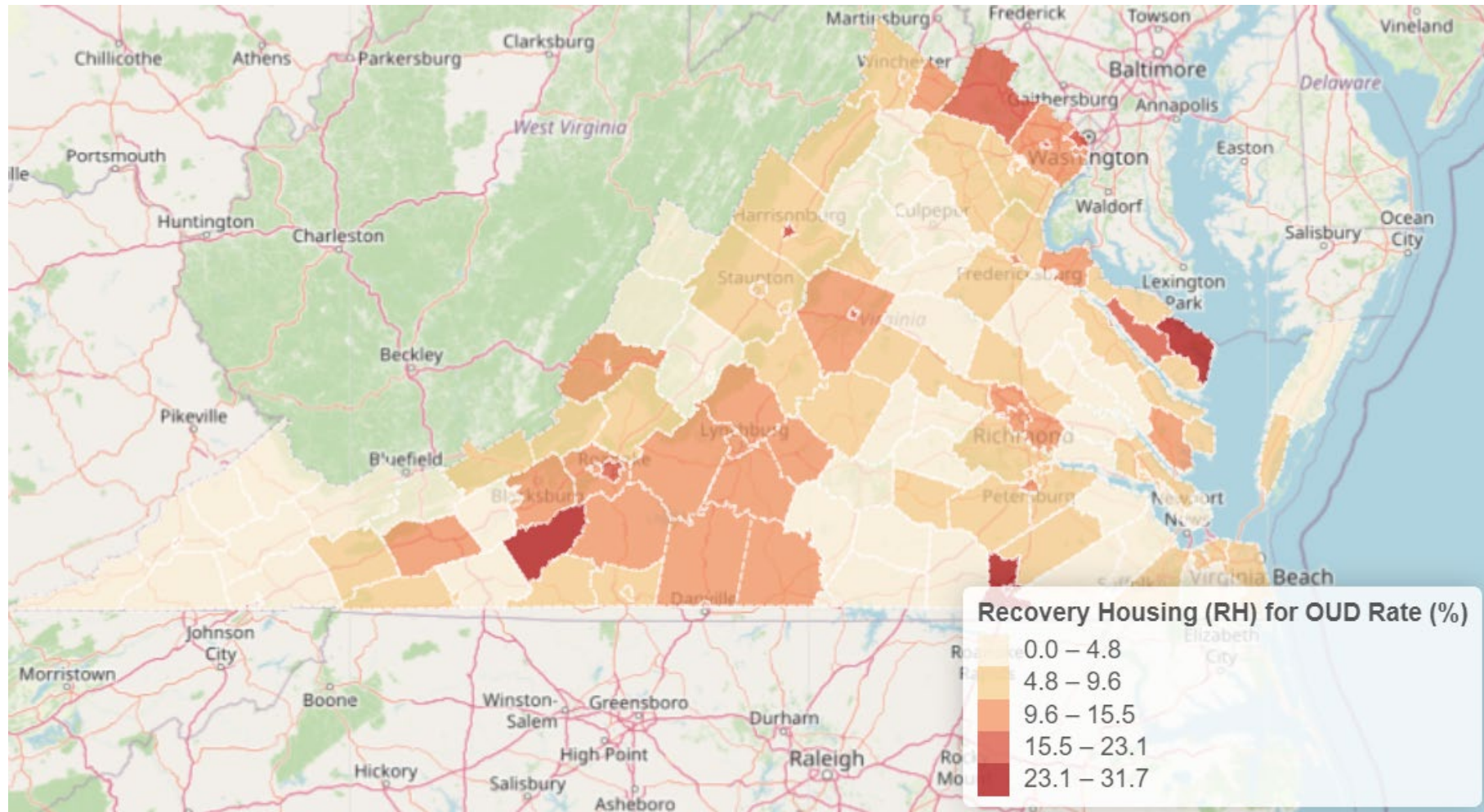
Rate of Counseling for All Individuals with OUD

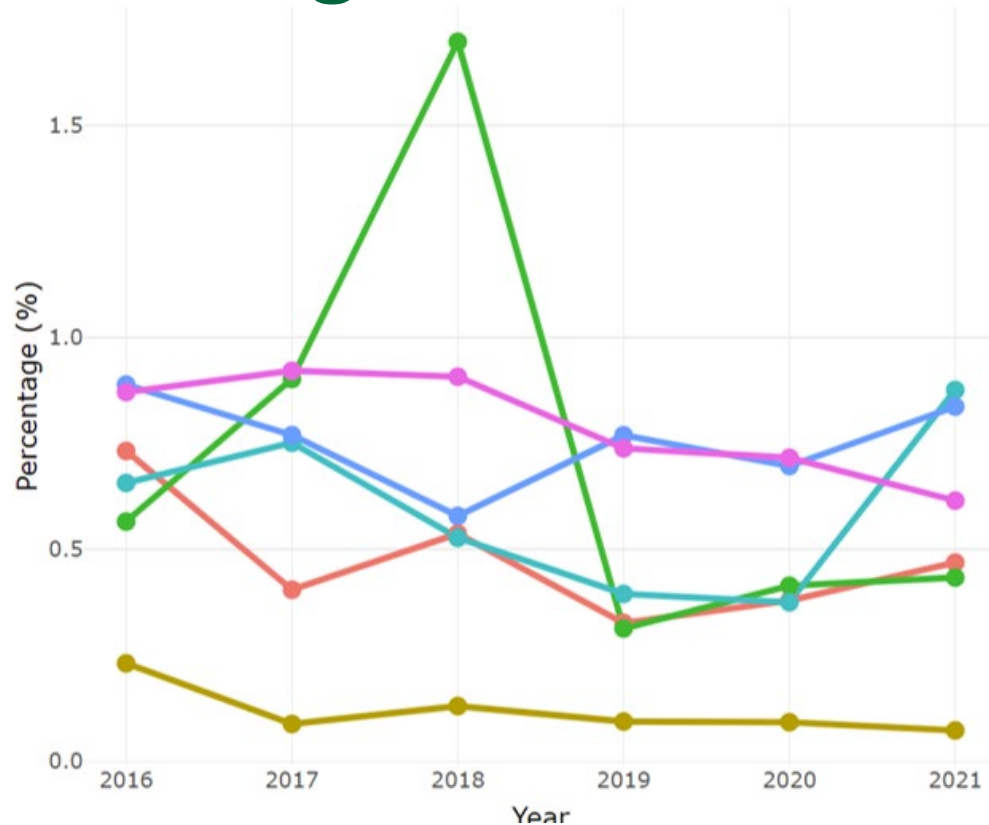
Rate of Recovery Housing Among All Individuals with OUD



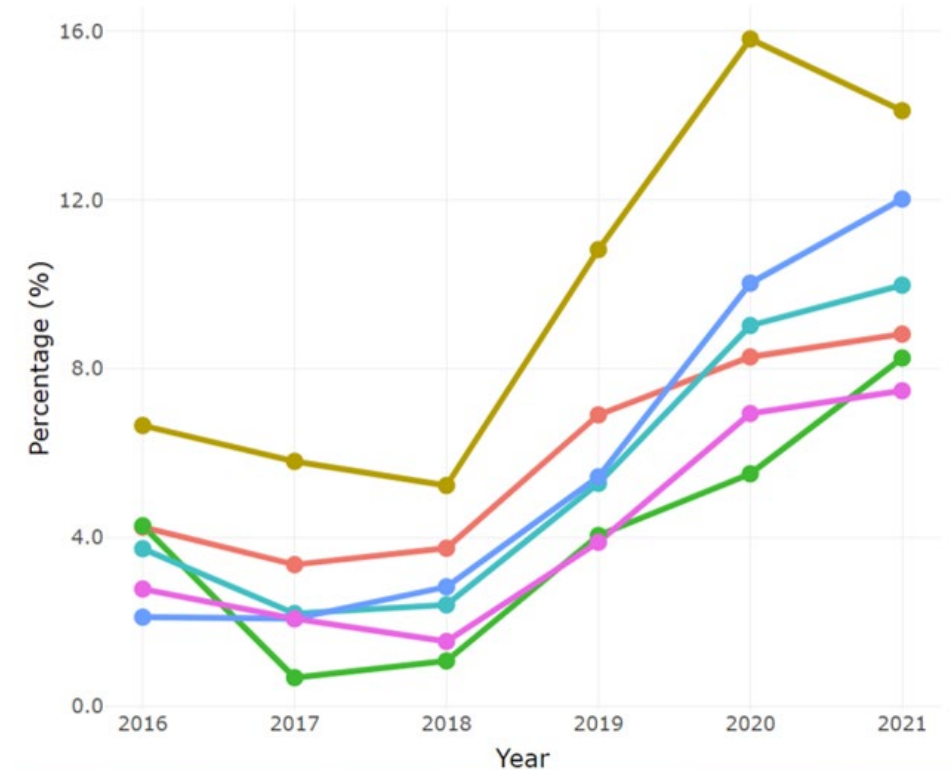

Assessing Trends Over Time

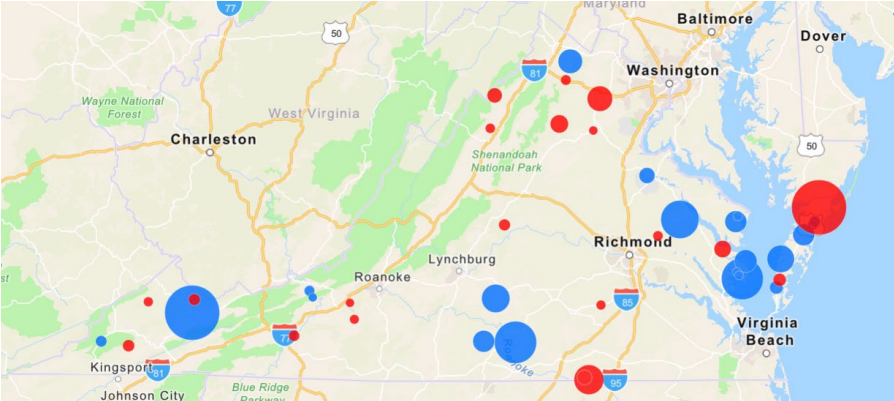


Rate of Neonatal Abstinence Syndrome by City/County

The Virginia Bright Spot Project

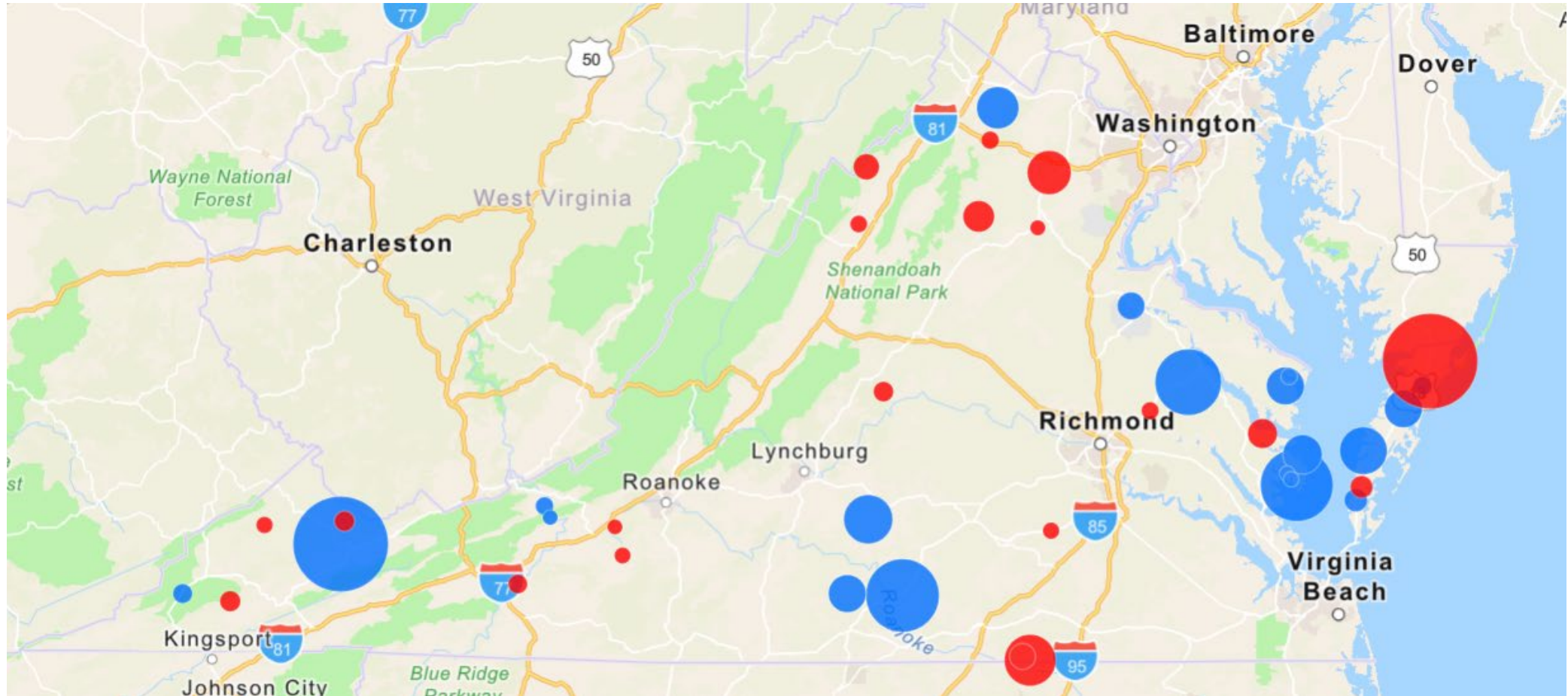


Our team aimed to identify communities with better-than-expected outcomes with regard to opioid use

Funded by the Virginia Department of Medical Assistance Services (DMAS) through a SUPPORT Act grant

(Better outcomes than predicted)

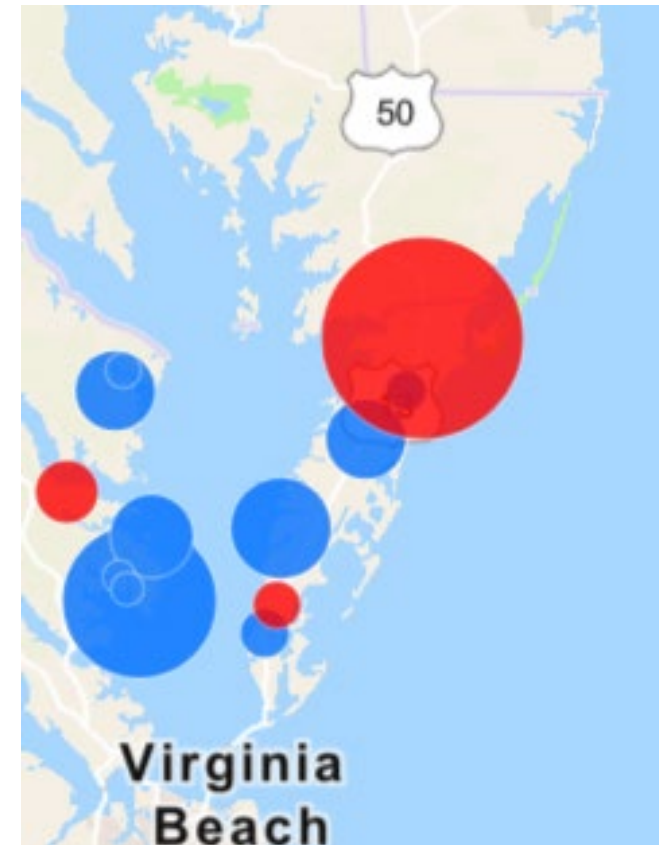
 Cold Spot

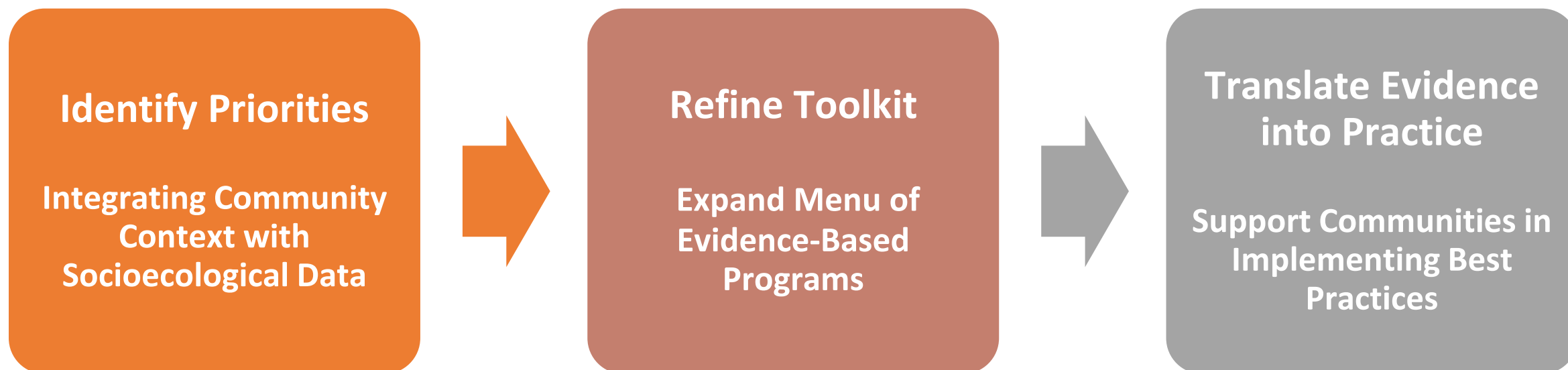

Eastern Shore Overdose Fatality Review Team

- **First overdose review team in VA**
- VA Legislation signed into law in April 2018
- **Years of community partnership and interventions at multiple levels:**
 - Mobile clinics (partner with food bank)
 - Weekly rounds with PCP/CSB
 - REVIVE trainings
 - Engaging housing and employment
 - Training for clinicians
